Neighborhood Concerns:

- Lake County has ordinances which address rodent problems caused by trash, abandoned vehicles, etc. at the residences in our community. Please be conscious of your property's upkeep.
- Burning items other than dry leaves and branches has been occurring in the neighborhood creating nuisance, and in some cases, toxic smoke. The board has contacted Lake County and Kathleen O'Connor, Libertyville Township supervisor, regarding commercial burning in the neighborhood and asked for guidance if it continues to occur. Be polite when burning. We don't want to lose the privilege of social bonfires.

- Drainage problems still exist on Des Plaines Road. The township was notified last year
 of a culvert that was paved over, thus blocking water flow. The issue has not been
 rectified. Kathleen O'Connor has been contacted and will ask the road
 commissioner, Marty Neal, to investigate.
- The cost of flood insurance is set at 1% the value of the home. Because of the confusion regarding flood insurance in the neighborhood, how it affects property tax assessments, and the sale ability of neighborhood properties, Brad Schneider has been asked for a community presentation by FEMA. FEMA has restricted the meeting size to NLECA board members and one or two homeowners. Your NLECA board members will present questions from North Libertyville Estates and surrounding areas. Please submit all questions, with your address, to kathiemachado6@gmail.com by April 15 at noon. A set of questions and answers will be emailed to residents who are enrolled on the nleca.org email list.
- Questions regarding new construction of garages, outbuildings and fences were raised. These issues should be directed to the township at (847) 918-2028 for clarification. It is possible that some restrictions have been changed over time.

A playground cannot be built at David Park due to insurance and liability issues.
 Matigian Preschool, on Center and Buckley Road, has a playground on their property. Volunteers will inquire if Matigian would be willing to share their playground after business hours with the North Libertyville Estates community.

Mosquito Spraying:

Additional mosquito spraying will be ordered this year if membership nears 50 households. A membership count of 50 households almost covers the spraying costs. The additional cost of spraying will be taken from pond funds. Mosquito Dunks are available at Ace Hardware or free of charge from the Township office.

Sign Replacement:

Board treasurer, Lori Harper, and volunteer, Kevin Mach, designed, assembled, and installed a new sign at the entrance of East End Avenue and Buckley Road. The sign has generated many compliments and adds value to the community. The feasibility of a second sign to be placed at the corner of Des Plaines and Buckley is being explored. The original sign was destroyed by an automobile 2 years ago.
